Management of acute dental pain is accomplished through a clinical approach that successfully incorporates opioid and non-opioid analgesics. It is critical for clinicians to accurately identify the need for pain control, individualize patient care and assess the efficacy of the analgesic agents to be administered. This program will provide an overview of the effective management of acute dental pain. Using case scenarios, special emphasis will be given to appropriate utilization of opioid analgesics and their impact on the dental community. This program will introduce the dental professional to the most current information regarding vaping as a route of administration for various substances, including nicotine and cannabis, as well as adverse effects, and effects on dental treatment.

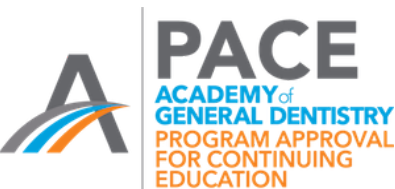

Promoting the HPV Vaccine: An Opportunity for Medical-Dental Collaboration introduces evidence-based practices for promoting the HPV vaccine in the population. The session will also address the increasing prevalence of HPV-associated oropharyngeal cancers and offers an interdisciplinary approach to increase the HPV vaccine in a healthcare setting. Examples of effective communication with parents regarding the HPV vaccine will be discussed.

Integrating genomics at the population health level has the potential to increase our understanding of disease, improve public health, reduce health disparities, and promote genomic literacy. Current evidence for certain genomic applications suggests that many lives could be saved now if these were implemented in the recommended populations. This presentation will focus on the existing evidence and clinical utility of genetic applications for specific populations. Examples of public health genomics implementation efforts by the Centers for Disease Control and Prevention, National Academy of Medicine, state public health departments and health systems will be explored. The importance of addressing health disparities will also be highlighted. Genetic syndromes with relevance to dental public health practitioners will be included when possible. Possible ways for individuals with expertise in oral health to become involved in existing precision public health efforts will also be discussed.

Obstructive sleep apnea (OSA) is an underdiagnosed medical condition with potentially serious morbidities. Dental professionals and other healthcare professionals can be instrumental in recognizing the signs and symptoms of OSA. This presentation will cover diagnosis and treatment options for patients suffering with obstructive sleep apnea.

The Centers for Disease Control and Prevention has praised community water fluoridation (CWF) as one of 10 “great public health achievements of the 20th century,” recognizing that this health practice reduces tooth decay by 25% over a person’s lifetime. Yet we cannot take CWF for granted. Although fluoridated water reaches most Texans, some communities have stopped adding fluoride in recent years. Research shows local residents will suffer because of these decisions to stop. Being an effective public advocate for CWF requires two proficiencies: 1) understanding the scientific evidence, and 2) using strategies that strengthen communication. This session will provide participants with both proficiencies. This session will conclude with a role-play exercise giving participants a chance to practice the skills they have learned.

Upon completion of this event, participants should be able to:

- Explain how topical fluoride (fluoridated toothpaste, mouth rinses, professionally applied varnish, and water fluoridation) and systemic fluoride (optimally fluoridated water, fluoride supplements) work in complementary ways to reduce dental caries.
- Communicate what recent research has concluded about the effectiveness and safety of fluoride at the concentration in fluoridated drinking water.
- Recognize the common claims that critics make against the practice of community water fluoridation and why these claims are not supported by evidence-based scientific research on optimally fluoridated water.
- Educate the public about community water fluoridation using best practices for communicating to audiences with limited health literacy.

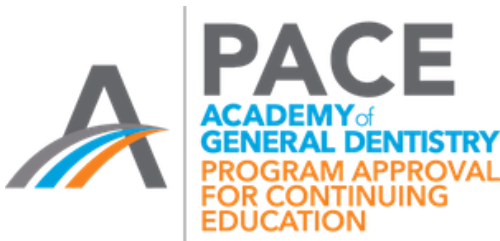

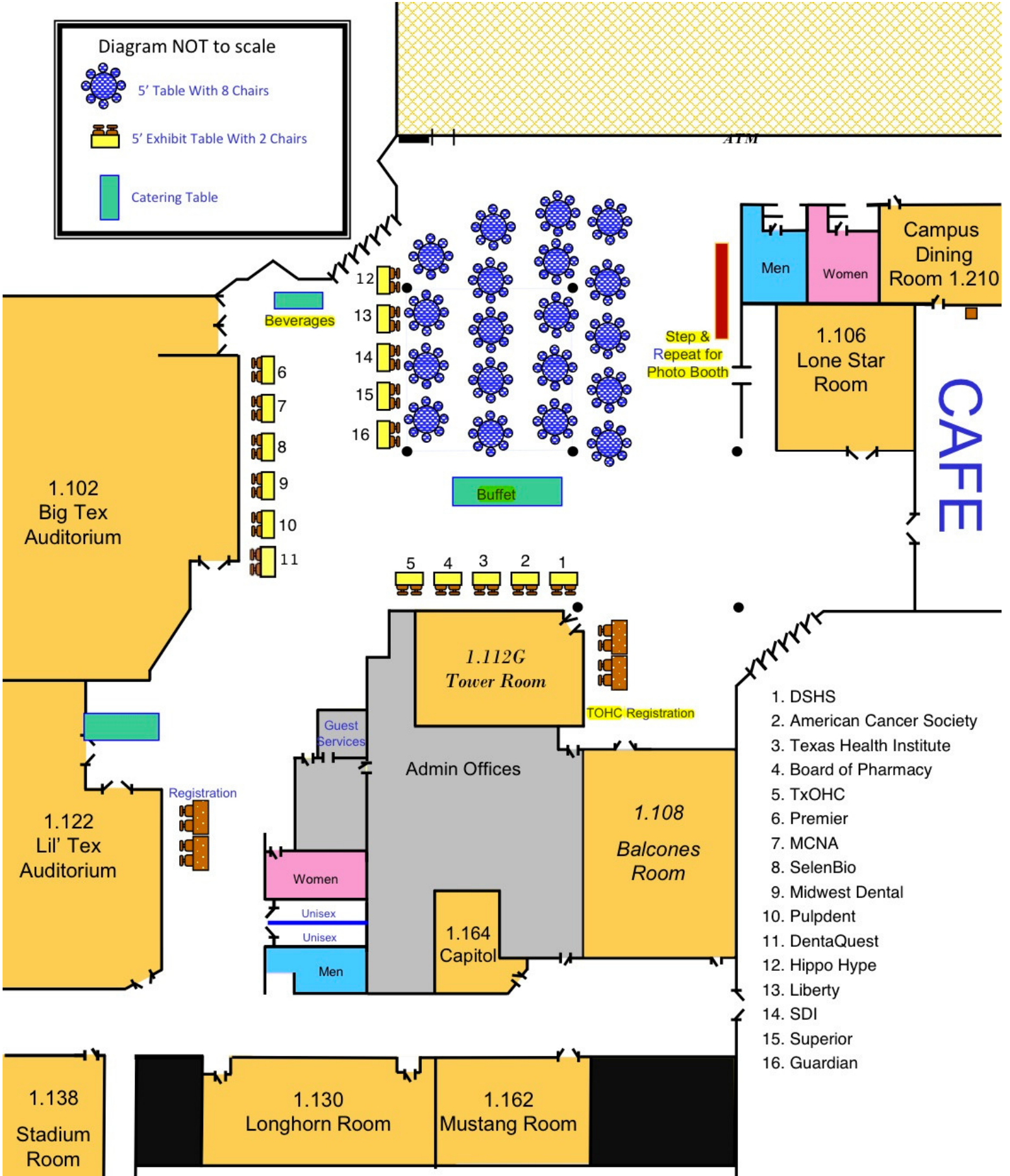
